Abstract: An in-person meeting of the Expert Panel was held at NatureServe's headquarters in Arlington, VA. We were especially pleased that Jean Brennan was able to join us for the full meeting. Each of the Panel's three work groups (downscaled climate data [Patricia Butler and Healy Hamilton]; methods assessment [Kyle Barrett and John O'Leary]; and criteria for selection of species and habitats for vulnerability assessment [Kim Hall, Hector Galbraith, and Bob Cooper] presented and reviewed pertinent materials. Following the presentations, each group worked independently to write the draft text of the report on the guidance document. Drafts were then shared with the larger group. Following the meeting, we developed an ambitious timeline to complete the final report, a draft of which is now complete.
