Abstract: We met our expected delivery date of May 15 for submission of our draft Expert Panel recommendations report. We received extensive comment from Jean Brennan, who requested more concrete recommendations and more detailed critical analysis of existing methods.

Were planned goals/objectives achieved last quarter? Not completely. Our Expert Panel draft report was submitted by the revised expected date; Jean Brennan made a request for more explicit recommendations, as well as more detailed critique of existing methods. We then had further communications with the Panel, including emails and conference call, to elicit this information. Draft report was revised extensively and has been circulated to the Expert Panel as of July 25. Anticipated date of completion: August 30, 2013. Selection of species and habitats has been delayed but is under way, and at this time, we do not anticipate a delay in the original date of completion (April 30, 2014).
