<u>Abstract</u>: We added a new member to our Expert Panel, Patricia Butler of the Climate Change Response Framework for the Appalachians, out of the Northern Institute of Applied Climate Science, Michigan Technological University School of Forest Resources. The Panel organized itself into three work groups: downscaled climate data (Patricia Butler and Healy Hamilton); methods assessment (Kyle Barrett and John O'Leary); and criteria for selection of species and habitats for vulnerability assessment (Kim Hall, Hector Galbraith, and Bob Cooper). Each of the work groups assembled information in preparation for the in-person meeting scheduled for January 14-15, 2013 at the NatureServe Home Office in Arlington, VA. We received our report of completed assessments in the Appalachian LCC from the New York Natural Heritage Program, which included assessments of over 600 species in NY, WV, PA, and southern Appalachians. We also developed a draft of narrative descriptions of methods whieh will be expanded upon in the coming months. Numerous citations were assembled and pdf's of the literature sources made available to the Expert Panel through Google docs.

Our goals are to:

- 1. Provide recommendations to the Appalachian LCC regarding climate change vulnerability methods most appropriately used in the AppLCC region.
- 2. Apply the recommended methods to conduct climate change vulnerability assessments on selected species and habitats in the AppLCC

We will accomplish this through the following objectives:

**Planned:** Finalize panel membership of LCC coordinator recommendation; plan for January meeting **Actual:** Patricia Butler agreed to join our expert panel, and she was introduced to the panel on our October 16 conference call at which we formed three subgroups: downscaled climate data; comparison of methods; and criteria for selection of species and habitats for assessment. Two

subsequent calls were held: review of workgroup progess (November 29); workgroup reports; review of draft final report outline, and plans for January meeting to be held January 14-15 at NatureServe Office in Arlington, VA (December 20)

**Planned:** Methods workgroup to develop spreadsheet with criteria to assess components of vulnerability assessment methods, and begin assessment of methods

Actual: We developed a draft of narrative descriptions of methods which will be expanded upon in the coming months. Numerous citations were assembled and pdf's of the literature sources made available to the Expert Panel through Google docs.
